This Terms of Use was last updated on April 19, 2024.

Seek Health Group, Inc. (“Seek,” “Company,” “we,” “our,” or “us”) is a technology company that provides a platform and services to women who want to learn more about how alcohol impacts their health. Our platform provides access to the Seek website, located at [www.seekhealthtest.com](http://www.seekhealthtest.com) (the “Website”), and individual testing services, including biological sample collection, analysis and results.

Seek does not provide clinical services or lab review services. Seek contracts independent third-party partners to perform testing services, including biological sample collection, analysis and results. Seek is not a healthcare provider and does not provide medical advice or claim to diagnose, treat, cure or prevent any disease or illness.

These Terms of Use (the “Terms”) are entered into between you (“you,” or “user”) and Seek Health Group, Inc. These Terms govern your access to and use of Seek’s Website, products, testing services, collection, analysis of biological samples, research and content (the “Services”) provided by Seek

### **TESTING SERVICES**

As stated above, Seek does not provide lab review services. Seek contracts independent laboratory partners (the "Lab") to perform testing services, including biological sample collection, analysis and results.

You may use an at-home sample collection kit (the "Kit") to collect biological samples (a "Sample"), then send them to Seek and its laboratory partners for testing and analysis. Seek or its laboratory partners work with health care providers who are licensed in all 50 states (the "Reviewing Provider") to review your request for at-home testing, collection and analysis. When the Reviewing Provider approves your lab order, your kit will be shipped to the address you provide. To successfully complete the lab order process, you must follow the instructions packaged with your kit (e.g., register your kit, collect your biological sample, return your biological sample for analysis).

Your biological sample is returned to the Reviewing Provider, who releases your test results to Seek. Seek's proprietary technology analyzes your test results and self-reported insights to provide personalized recommendations via Seek's website, [www.seekhealthtest.com](http://www.seekhealthtest.com), Seek's web application, [www.my.seekhealthtest.com](http://www.my.seekhealthtest.com), and other methods of communication. Any personalized recommendations derived from the analysis of your Sample and your self-reported information are for informational and educational purposes only. Samples are processed in an irreversible manner and cannot be returned to you once submitted for testing. No refunds will be given for any Kits after your Samples have been sent to Seek for processing.

Sometimes, Seek may not be able to process a Sample or our testing process may result in errors due to several reasons which may include but not be limited to Samples containing insufficient volume or the testing results not meeting our standards for accuracy ("Sample Failure"). This may result in unexpected delays in processing your Sample. On such occasions, Seek will notify you of the Sample Failure and details applicable to processing a new Sample in place of the failed Sample.

By using Seek's testing services, you understand and agree that testing services provided by Seek and its lab partners are intended for informational and educational purposes only. The Services are not intended to be diagnostic or prescribe, treat or diagnose a health condition. You further

understand and agree that you are not intended to establish a provider-patient relationship with the Reviewing Provider and it is your responsibility to bring your test results to a healthcare provider for interpretation and actionable decisions regarding your overall health and treatment.
